- 3. All persons connected with the operation of this game must be provided with appropriate instruction, procedures and information required for the correct operation of this game.

THE ADELAIDE CASINO
RULES FOR POKER
TEXAS HOLD'EM
WITH JACKPOTS



#### 1. **DEFINITIONS**

The following words and terms used in these Texas Hold'em Poker rules shall have the following meanings:

- "Act" To check, call, bet, raise, re-raise or fold, or to announce an intention to make such an action.
- "Add-on" An option during a tournament to purchase more chips.
- "All-In" Being all that is possessed by a player as a table stake. A wager of insufficient means to enable the player to continue in the betting but which is made so as to allow that player to remain active in the game.
- "Ante" means a wager or pre-determined contribution to the pot made prior to any cards being dealt.
- "Area Manager" means the person, other than the Casino Manager, who is responsible for the supervision of the operation of the game.
- "Bet" means to make a wager.
- "Betting Round" a complete round of betting in which all active players have made an equal contribution to the pot (excluding players that are "all-in").
- "Boxed Card" A card face-up in the deck.
- "Blind" A wager or pre-determined contribution to the pot made prior to any cards being dealt.
- "Burn Card" a card dealt facedown prior to the dealing of the flop, the turn and the river cards.
- "Call" A wager made in an amount equal to the immediately preceding wager.
- "Cash Game" A non tournament game played with cash/value chips (alternatively called 'ring game' or 'live game').
- "Check" means to abstain from betting, but continue to stay in contention for the pot by retaining the right to call after all other players have either wagered or folded. A check may not be made should a wager have been made in the round.
- "Community Cards" are the face up cards in the middle of the table. These are cards shared by the active players and may be used with any of the players hole cards to form the best five-card poker hand.
- "Cut" the separating of the deck, by the dealer into two portions then rejoining those two portions in the opposite order in which they were separated. Each portion shall have more than one card. The initiation of this action indicates the commencement of a hand.
- "Dead Blind Bet" A (small) blind bet that is inactive and forms part of the pot.

  A "Dead Blind Bet" does not constitute part of a players wager.
- "Dead Hand" A hand that has no claim on a pot.
- "Dealer" means the person responsible for dealing the cards at a Texas Hold empoker table.
- "Dealer Button" A marker to indicate the player to receive cards last.

- "Declarations" Verbal declarations made by a player are binding. A player declaring 'fold' has a dead hand.
- "Deck" a standard 52 card pack of playing cards
- "Entry Payment" the total cost of entering a tournament
- "Express Tournaments" a tournament in which players are given a limited amount of time to act on their hand.
- "Fold" means to not call a bet or surrender a hand. A 'folded' hand shall only become a dead hand upon making contact with the muck (face down), or upon a player's declaration of 'fold'.
- "Flop" the first three community cards, dealt simultaneously at the conclusion of the first betting round.
- "Freeze-out" a tournament without re-buys and/or add-ons
- "Free-Roll" a tournament that does not have an Entry Payment
- "Hand" One game in a series, one deal in a poker game or the cards held by a player.
- "Heads-up" When only two players remain in the betting.
- "In Kind" A prize awarded to a player other than cash paid for from the prize pool contributions.
- "Initial deal" the dealing of two cards to each player. The initial deal is complete when the player in the dealer button position has received two hole cards.
- "Killed" Make a hand null and void (by mucking).
- "Limit" A wager made to a pre-determined amount greater than the immediately preceding wager.
- "Live Blind Bet" A small blind bet, a big blind bet, or a straddle bet made that is active a live bet for the first betting round.
- "Misdeal" means that the cards have been dealt incorrectly and the round of play will be void.
- "Muck" The pile of folded cards. To place cards (facedown) into this pile. Facedown cards become dead upon making contact with the muck.
- "Over-Chip" A single chip used that is equal to or greater than that required to make a legitimate raise.
- "Casino Manager" means a person, other than an Area Manager, who is responsible for the supervision and management of gaming operations.
- "Play" means that the player elects to remain in the game by placing an additional wager after the cards have been dealt and he/she has had an opportunity to look at his/her hand.
- "Prize Pool Contribution" the portion of a tournament 'Entry Payment' that forms the prize pool.
- "Pot" The total amount wagered by players during a hand.
- "Raise" To make a bet increase during a betting round.
- "Re-buy" An option given to tournament players to buy more chips after


dropping below a certain amount or losing all of their chips.

- "River" the fifth community card.
- "Adelaide Casino Entry Fee" the portion of a tournament 'Entry Payment' retained by the Adelaide Casino as a charge for conducting a tournament.
- "Soft Play" Not betting a strong hand in a collusive manner.
- "String Bet" A string bet is an unannounced bet or raise made in more than one motion. String bets are not a legitimate bet or raise.
- "Straddle" a bet equal to double the big blind (or previous straddle) made by the player first to the left of the big blind (or previous straddle). This is a voluntary bet made before the cards are cut. This player shall be given the right to act last in the first betting round. Up to one straddle bet per player is permissible.
- "Substantial Action" Actions in turn, by two or more players, i.e. check, bet, raise, re-raise, call or fold.
- "Tabled" A hand laying completely face up on the table.
- "Tournament" A game comprising a series of hands to determine the overall winner(s).
- "Turn" the fourth community card.
- "Trivial Chip" A chip of a denomination that is of a value that is less than that used to make a legitimate bet (including blinds and antes).
- "Unprotected" Cards that have been left on the table that are positioned in such a way that it is not obvious that a player wants to play them.



# **TABLE LAYOUT**

The poker tables shall be similar to the design shown below and shall have a place for a seated Dealer and places for seated players.





# **CONTROL OF THE GAME**

3. The Dealer shall be responsible for the conduct of the game in accordance with these rules. The Dealer shall control all cards/hands, determine winners and distribute their winnings. The Dealer shall be responsible for collecting any charges. Final control of the game lies with the Casino Manager in charge of the poker area, who shall correct any errors in procedures or payouts.

# THE CARDS

- The game of Texas Hold'em poker shall be played with one complete (52 card) deck 4. without Jokers and with backs of the same colour and design. When a table has been made (a minimum of two players) or when a new deck of cards is introduced into the game, the cards shall be checked, card by card, by the Dealer. After the cards have been inspected by the Dealer the cards may be inspected by an Area Manager and/or Casino Manager. Before the initial shuffle the Dealer must chemmy shuffle the new deck. Before each hand the Dealer shall shuffle the deck of cards on the table without disclosing any card so that they are randomly intermixed. After the cards have been shuffled, the Dealer shall cut the cards and place them on a cutting card in preparation for play. The cut must be made more than one card from either end of the pack and in full view of the players. An approved shuffling machine may be used to randomly intermix the cards prior to the initial deal. In the event of a complete machine failure the game will continue manually in accordance with the rules of Texas Hold'em poker. At any time that the cards become jammed in the shuffler, the cards will be removed from the machine to clear the jam, checked for damage and placed back into the shuffler to allow the game to continue.
- 5. a. A new deck of cards shall be introduced after a showdown if:
  - i. A majority of Players request a change, or
  - ii. A card or cards become mutilated, or
  - iii. At the Area Manager and/or Casino Manager's discretion.
  - b. When a new deck is introduced the new deck shall be a different colour to the one used previously.
- 6. Cards may be pre-checked and secured in a designated area until such time as they are required for use in play.

# **VALUE OF CARDS**

- 7. There shall be no distinction between the suits and the game shall not be played with a reduced deck.
- 8. Rank of cards A, K, Q, J, 10, 9, 8, 7, 6, 5, 4, 3, 2, subject to Rule 43 f.



### DEAL

- 9. A Dealer Button shall designate the player who is last to receive the cards of each hand. At the commencement of play the player to the Dealer's immediate left will be given the Dealer Button. The Dealer Button shall be passed clockwise around the table at the end of each hand.
- 10. Players will have choice of seat. In the event of two or more players desiring the same seat, a draw of cards will decide seating positions. When a player leaves the game the remaining active players have priority in an anti-clockwise direction from the Dealer Button over any player waiting to join the game, to move to the vacated playing position.
- 11. The game shall be played in the following sequence:
  - a. Prior to the cards being dealt on the initial deal, the players to the immediate left of the dealer button will place blind bets as outlined in Appendix 1. Each player, including the blind bettors, prior to the cards being dealt on the initial deal, shall place antes (if used) as outlined in Appendix 1.
  - b. The Dealer shall then deal, in a clockwise direction to each player starting with the player to the immediate left of the Dealer Button position, one card face down. He/she shall then repeat this process until all players have two cards. These cards shall be known as the hole cards.
  - c. The first betting round shall then take place.
  - d. At the completion of the first betting round the Dealer shall then burn a card then deal the flop three cards face up in the middle of the table. Cards dealt to the middle of the table shall be known as community cards.
  - e. The second betting round shall then take place.
  - f. At the completion of the second betting round the Dealer shall then burn a card and then deal a fourth community card face up in the middle of the table.
  - g. The third betting round shall then take place.
  - h. At the completion of the third betting round the Dealer shall burn a card then deal a fifth community card face up in the middle of the table.
  - i. The final betting round shall then take place.
- 12. A player's completed hand shall comprise the best five card combination using none, one or two of his own hole cards plus five, four or three of the community cards.
- 13. It is the player's responsibility to ensure their hand contains the correct number of cards. Failure to do so will result in the player holding a Dead Hand and the player will have no redress. If a player is yet to act on their hand, they will be entitled to receive any wagers, forced bets or blinds back. If the affected player has made any action of check, call, raise or fold, any wagers, forced bets or blinds will remain in the pot.

#### THE BETTING

- 14. Texas Hold'em shall be played using at least two blind bets per Appendix 1 and Rule 29 whether the limits are 'Appendix 1 Texas Hold'em Limits' or any of the 'Appendix 1 Alternative Limits'.
- 15. All bets and raises must be equal to or greater than the previous legitimate bet or raise in the same betting round, except where the person under-raising is a player going all-in (see Rule 48).

#### THE FIRST ROUND OF BETTING

- 16. When all players have received their hole cards, the player to the left of the big blind position, in accordance with Appendix 1, shall have three options:
  - a. Call (equal the amount wagered by the previous bettors).
  - b. Raise (equal the amount wagered by the previous bettors, plus an additional amount within the betting limits outlined in Rule 29).
  - c. Fold (turn his cards face down on the table, pass them in and take no further part in the hand).
- 17. Each player in turn (subject to rule 18) shall follow the procedure in Rule 16 until:
  - a. Only one player remains in the game. He wins the pot.
  - b. Two or more players have put an equal amount into the pot.
- 18. In the first betting cycle of the first round the players seated in the blind positions shall in accordance with Appendix 1, at their turn, have the following options:
  - a. Call (equal the amount wagered by the previous bettors).
  - b. Raise (an amount within the betting limits outlined in Rule 29).
  - c. Fold (keep his hole cards face down, pass them in, and take no further part in the hand).
  - d. Check, if in the big blind position and no one has raised.
- 19. If two or more players are still in the hand and all bets have been met by these players, the Dealer will deal three community cards face up, and the second round of betting will take place in accordance with Rule 15 and Rule 16 a., b., and c.

#### THE SECOND AND THIRD ROUNDS OF BETTING

- 20. The first active player to the immediate left of the Dealer Button will be the first to bet, or check in accordance with Rule 40. Thereafter the other players may, in accordance with Appendix 1 and Rules 41 and 42, have four options:
  - a. Check
  - b. Call (equal the amount of the wager by the previous bettors)
  - c. Raise (bet an additional amount within the betting limits).
  - d. Fold (keep hole cards face down, pass them in, and take no further part in the hand).
- 21. Play continues until the pot is won or all five community cards have been exposed.



#### THE FINAL ROUND OF BETTING

- 22. a. After the fifth community card is exposed the first active player to the left of the Dealer Button will play as provided in Rule 20 until, subject to Rule 48, all remaining players have wagered an equal amount. The player being called may then expose his hole cards. Should a player or players have, or believe they have a hand of higher value, these should then be tabled, then the Dealer will announce the winning hand.
  - b. A player must table both hole cards to contest a showdown including when only using the five community cards to make their best poker hand.
- 23. A called player may surrender their hand by folding it face down, however upon request by another player that had called the final bet of the final round of betting, these cards may be opened by the dealer.

Should a player with a losing hand that had called the final bet in the final round of betting, ask to see the called player's cards prior to those cards touching the muck, then those cards shall be exposed but remain a dead hand.

Should a player that holds live cards call the final bet in the final round of betting and ask to see a called player's hand prior to that hand touching the muck, the called player's hand shall be exposed and remain active, subject to rule 74a.

- 24. Should the final betting round be 'checked', the first player to expose his hole cards shall be the first player to the left of the dealer button. When there can be no betting during the final round of betting because a player or players are 'all-in', the first player to open their cards shall be the last called player in the earlier betting round in which the remaining player or players became 'all-in'. Should a player or players have, or believe they have a hand of higher value, these should then be tabled and the Dealer will announce the winning hand.
- 25. Before passing the pot to the winning player(s) the Dealer will deduct the correct house commission in accordance with rule 78, and place these chips in a separate commission tube prior to being accounted for in the table inventory.
- 26. When two or more players hold the highest hands of equal value, the pot, after the house commission has been deducted, shall be equally divided between them subject to Rule 58 and Rule 59 a and b.



#### **MISDEALS**

- 27. On completion of each showdown the cards will be shuffled in accordance with Rule 4 and then the game continues with a new deal as per Rules 9 and 11
- 28. Wherever a misdeal occurs there must be a new shuffle and cut. The same player will be first to receive cards in the new deal as in the previous misdeals.

  A hand may only be deemed a misdeal (per below) prior to substantial action taking place.

There is a misdeal:-

- a. If one or more cards are exposed in cutting.
- b. If the Dealer deals the hole cards out of turn and the wrong player has looked at either.
- c. If two or more cards are exposed during the initial deal.
- d. If the Dealer deals too few or too many hands and the deal cannot be reconstructed (see Rule 46).
- e. as per Rule 54.

# **BETTING LIMITS**

The game is played with a minimum of two blind bets and betting limits as outlined in Appendix 1.

### **TABLE STAKES/WAGERS**

- 30. Each player when joining the game shall place their table stake on the table, in chips. The minimum and maximum buy-in will be displayed by a notice at or near the table.
- 31. A player's table stake must always be kept clearly visible and in readable stacks with higher denomination chips in front and/or on top of lower denomination chips
- 32. Wagers may only be made with chips.
- 33. A player shall not augment his bank during any hand.
- 34. Before any hand is dealt a player may buy more chips and/or augment his bank, providing it is within the buy-in range for that game.
- 35. a. A player shall not remove any of his chips from the table until he finishes playing the game and leaves the table, save to purchase goods or services from a Casino employee.
  - b. A player may not make any purchases from a table stake whilst an active player in a hand.
- 36. Under no circumstances shall a player be permitted to bet for another player.

# **TABLE STAKES/WAGERS - continued**

- 37. The minimum and maximum wagers shall be displayed by notice at or near each table.
- 38. Minimum and maximum wagers may be increased only by the agreement of all players at the table. Each player must ensure their table stake is within the minimum and maximum buy-in range for the new game.
- 39. All wagers including the blinds shall remain in front of the players until a betting round is complete.

# **CHECKING**

- 40. The first player, in all but the initial betting round, may check and let the player on his immediate left open the betting. He in turn may also check. If all players check, that betting round shall be over and the next card dealt.
- 41. No player can check after a bet has been made in that betting round.
- 42. All players will check, bet or fold in turn.

# **ORDER OF HANDS**

43. The order of hands in descending order shall be:-

a. Royal Flush: Fiv

Five top cards from each suit in sequence.

eg. A:K:Q:J:10: all spades

b. Straight Flush:

Five cards of the same suit in sequence.

eg. J:10:9:8:7: all hearts

c. Fours:

Four of a kind. eg. 9:9:9:9:Q:

d. Full House:

Three cards of one kind plus two of another.

eg. J:J:J:7:7:

e. Flush:

Five cards of the same suit.eg. K:J:10:8:7: All Clubs

f. Straight:

Any five cards in sequence not being a Flush.

An ace will count low in the combination 5:4:3:2:A

g. Threes:

Three cards of one kind. eg. 10:10:10:9:7:

h. Two Pairs

eq. J:J:10:10:8:

i. One Pair

eg. K:K:Q:9:8:

i. Five odd cards

eg. K:J:9:8:7:

44. In Rule 43 the rank of all cards count eg. Q:Q:9:9:7 loses to Q:Q:9:98:

45. The order of hands shall be displayed by a notice at or near each table.

#### **DEALING IN MORE OR FEWER PLAYERS**

46. If a Dealer deals a player out or deals an extra hand in and it is discovered before the players have looked at their hole cards and if the error can be corrected so that each player receives his proper cards (by shifting a card from one player to another and placing the extra cards or card back on top of the pack or dealing one or more cards from the pack without any of the cards being exposed to any player) there is not a misdeal. If the above conditions cannot be met then that hand is a misdeal.

### PROTECTING THE PLAYER'S HOLE CARDS

- 47. a. A player must protect the identity of his hole cards (first cards dealt face down) at all times, regardless of whether he is an active player or has folded. If the folding player's hole cards are exposed, the Dealer will expose the cards to the table. At the showdown the only hole cards that may be required to be exposed are those of the player called and those of any player or players calling who hold a winning hand (see rules 22, 23 and 24). Should a player calling at the showdown be satisfied he does not possess the winning hand, then he should pass his cards into the Dealer without exposing his hole cards.
  - b. If a Dealer mucks an unprotected hand, the player will have no redress and will not be entitled to his money back. An exception would be if a player raised and his raise had not been called yet he would be entitled to receive his raise back.
  - c. A tabled hand that was obviously the winning hand cannot be killed.

### **GOING ALL-IN**

48. A Player who does not have a bank of chips of sufficient value to meet a wager and wishes to stay in the hand must wager the remaining amount of his bank of chips and thus go all-in. He remains in the hand as an active player until the Showdown, taking no further part in any subsequent betting round or rounds. Any surplus above the amount wagered, at the time the person goes all-in, by other players will be placed in a separate pot. Should he have the highest-ranking hand on the showdown he wins only the initial pot and not the separate pot (or pots if two players go all-in during the same hand), which is won by the player having the highest-ranking cards amongst the remaining bettors.

Any wager must be at least the same size of the previous bet or raise in that round, unless a player is going all-in.

In limit play, an all-in wager of less than half a bet does not reopen the betting for any player who has already acted and is in the pot for all previous bets. A player facing less than half the bet may fold, call or complete the wager. An all-in wager of a half bet or more is treated as a full bet, and a player may fold, call or make a full raise.

For half-pot, full-pot or no-limit games all raises must be equal to or greater than the size of the previous bet or raise on that betting round, except for an all-in wager. A player who has already acted and is not facing a full size wager may not subsequently raise an all-in bet that is less than the minimum bet or less than the full size of the last bet or raise.

# **GOING THROUGH FOLDED CARDS/DISCARDS**

- 49. a. To preserve the integrity of a game, the Area Manager and/or Casino Manager may view a player's hole cards.
  - b. An Area Manager and/or Casino Manager will not display the contents of a player's cards via rule 49a

# **LOOKING AT UNDEALT CARDS**

50. A player shall not be permitted to look at the top card or any of the undealt cards at any time.

# **CHIP LENDING**

51. Chips cannot be borrowed or lent from a player's table stake.

# **DIVISION OF POTS**

52. The pot cannot be divided by the agreement of two or more players. Each hand must be played to a conclusion.

#### **TIME**

- 53. a. Once a reasonable amount of time as indicated by an Area Manager and/or Casino Manager has passed, a clock may be called for. A player will then be given 30 seconds to make a decision (excluding per games per rule 53 b.). If no action has been taken at the conclusion of 30 seconds, (excluding per games per rule 53 b.) there will be a 10 second countdown. If a player facing a bet has not acted on his hand by the time the countdown is over, the hand will be dead. If a player is not facing a bet and has not acted by the time the countdown is over, that player will be deemed to have checked.
  - b. Play during some cash games and tournaments may have a reduction in the time permissible to act on a hand. The time given to act on a hand in such games shall be determined by the Area Manager and/or Casino Manager and displayed on signage at or near the table. The dealer shall be responsible for monitoring the time taken by players and if a player facing a bet has not acted on his hand by the time the countdown is over, the hand will be dead. If a player is not facing a bet and has not acted by the time the countdown is over, that player will be deemed to have checked
  - c. A player may have the option to purchase additional time to make a decision as per rule 78(g).

#### **BOXED CARDS**

- 54. a. If a card to be used as a hole card is found face up in the pack or if the Dealer exposes a hole card in dealing the cards, then the card is to be put aside until the deal has been completed then the exposed card is to be swapped with the first burn card. If a second card is found face-up in the deck or exposed by the Dealer then it is a misdeal.
  - b. A card to be used as a burn card or a community card found face up in the deck shall be mucked and replaced with the next card from the top of the deck

# **FLOP/TURN/RIVER**

### 55. If the flop;

- a. Has too many cards, it shall be re-dealt after reshuffling and recutting the flopped cards and the remainder of the deck. The burn card shall remain.
- b. Has been dealt prior to the previous betting round being completed, it shall be re-dealt after reshuffling and recutting the flopped cards with the remainder of the deck. The burn card shall remain.
- c. Has been dealt after an incorrect amount of cards have been burnt it shall be re-dealt after re-shuffling and re-cutting the flopped cards together with, if applicable, the extra burnt card(s) and the remainder of the deck. If there has been substantial action, then the flop shall remain.
- 56. At the exposing of the fourth or fifth community cards;
  - a. If two (or more) cards are exposed when dealing the fourth community card, the correct card shall remain in play and the superfluous card shall be reshuffled with the remainder of the deck. The burn card shall remain. If two (or more) cards are exposed when dealing the fifth community card the correct card shall remain and the superfluous card shall be discarded. If it is not possible to determine the correct card, the community card shall be re-dealt after reshuffling and recutting the two (or more) exposed cards together with the remainder of the deck. The burn card shall remain.
  - b. If a community card has been dealt prior to the previous betting round being completed, it shall be re-dealt after reshuffling and recutting the community card together with the remainder of the deck. The burn card shall remain. If there is substantial action, then the community card shall remain.
  - c. If a community card has been dealt and the dealer burnt more than one card, the community card shall be re-dealt after reshuffling and recutting the community card together with the extra burn card(s) and the remainder of the deck. If there has been substantial action, then the community card shall remain
  - d. A burn card dealt as the turn or river card shall be retrieved and burnt prior to substantial action taking place. The correct turn or river card shall then be dealt. Should there be substantial action before the error is noticed, then that card shall remain.
- 57. If a player holds too few or too many cards during the betting round or at the showdown then his hand is void. If it is at the showdown and there is only one other player, then the player holding the correct number of cards wins the pot. If there is no other player remaining then the last player or players who folded during the final betting round wins the pot.

# **SPLIT POTS**

- 58. Where more than one player is to share a pot or pots in accordance with Rule 26 and if after the deduction of commission each player's share of the pot or pots is not wholly divisible by the number of such player's who are to share the pot or pots, then the player closest to the immediate left of the Dealer Button shall receive the higher value pot.
- 59. a. Where all the players who commence a hand finish the hand and win the pot and the pot is divided in accordance with Rule 26 then no commission shall be deducted from the pot or pots.
  - b. Where the deduction of commission would result in a winner of a pot losing, then no commission shall be deducted.

# **SEATING**

- 60. a. Permission is required from the Area Manager and/or Casino Manager before taking a seat at any table.
  - b. A non-player may not sit at a table.
  - c. Seating of players, balancing of tables and the operation of any waiting lists shall be at the Area Manager and/or Casino Manager's sole discretion.
- 61. If a player returns to the same game within 1 hour, then their buy-in must be equal to the amount they removed.
- 62. a. If a player has left the table, an Area Manager and/or Casino Manager may make the away player's seat available to a waiting player, when the away player is about to miss posting a big blind for a second time.
  - b. An Area Manager and/or Casino Manager may make the seat of a third player away from a table available to a waiting player.
- 63. An Area Manager and/or Casino Manager may require that any two players either not play in the same game or not sit next to each other at the same table (Husband and wife, relatives, business partners and so forth).
- 64. To avoid a seating dispute an Area Manager and/or Casino Manager may decide to start the game with one extra player over the normal amount permitted.



#### **POSTING BLINDS**

- 65. A player cannot pass his turn to post either blinds
- 66. a. players joining a game must either post a big blind or wait until they are in the big blind position to receive cards unless they:
  - i. Are joining a game that is in its' first lap of blinds from commencement of play
  - ii. Arrived from a table of the same game and betting limits, that has become defunct.
  - iii Were required to move tables as directed by an Area Manager and/or Casino Manager
  - b. A hand dealt to a player joining the game that has failed to post their blind bet, is dead if there has been any action. If the player that has failed to post has acted, then they shall be required to post prior to the next hand.
- 67. a. If a player has left the table and thereby fails to post their blind bet or bets, they must upon return post their missed blind bets to resume playing or wait until they are in the big blind position. A player wishing to resume playing immediately must post a dead small blind in addition to a live big blind.
  - b. A hand dealt to a player re-joining the game that has failed to post their blind bet or bets, is dead if there has been any action. If the player that has failed to post has acted, then they shall be required to post prior to the next hand.

#### **RAISING - 'HEADS-UP'**

68. In a Fixed Limit game, unlimited raising is allowed in heads-up play (except per rule 98). This applies at any time where action becomes heads-up before the raising has been capped. Once the raising is capped on a betting round, it cannot be un-capped by a subsequent fold that leaves two players heads-up.

# **OUT OF TURN BETS**

- 69. a. A player checking out of turn may not bet (unless calling) or raise.
  - b. If a player bets, calls or raises out of turn, that wager shall stand irrespective of any preceding action. If the out of turn player does not wish to call any further wager and fold, then the amount already wagered by the out of turn player shall be forfeited to the pot. An out of turn player that is facing a larger bet or raise, may call or fold only.
  - c. If an out of turn player's wager is insufficient to constitute a full size raise, then any other player who has already acted and is not facing a full raise may not subsequently re-raise the out of turn player's bet. Any other player that has not acted, still has all normal options.

# BETTING/CALLING/RAISING IN ERROR

70. A player calling in error with an amount half or more of that required to make a legitimate call shall be required to complete the call or forfeit their hand and those chips already used. Such a player may not raise.

A player calling in error with an amount less than half of that required to make a legitimate call may withdraw those chips already used or complete their call but may not raise.

A player betting or raising in error with an amount half or more of that required to make a legitimate raise, shall be required to complete a minimum raise only, or forfeit their hand and those chips already used.

A player raising in error with an amount less than half that required to make a legitimate raise shall be deemed to have called and may not raise.

# **STRING BETS**

71. 'String bets' are not a legitimate bet or raise and may not be accepted. Players when betting or raising, must either put the amount of the bet or raise out in one motion or announce their intention to raise by stating 'raise'. In half-pot, pot-limit or no-limit games a player must announce the amount of the bet or raise, or place the bet or raise out in one motion.

#### **CHIPS**

- 72. a. Over Chips. A single chip of greater value than that required to call shall be deemed a call unless preceded by an announcement indicating an intention to raise.
  - b. Trivial Chips. For particular tables/games, the Area Manager and/or Casino Manager may, at their sole discretion, deem that trivial chips do not play unless a player has enough such chips to make the smallest legitimate bet (blind or ante) permissible for a particular game.

# **TABLE TALK**

73. Players, whether in the hand or not, may not discuss a hand in progress until the action is complete. Discussing hand possibilities or cards discarded is not allowed.

#### **DECLARATIONS**

- 74. a. Verbal declarations fold, check, call, bet, raise, re-raise, all-in are binding. A player declaring 'fold' has a dead hand.
  - b. A player's hand knocking or tapping the table is deemed a declaration of 'check' and is binding.
  - c. Invalid Bet Declarations, if a player faces no bet and;
    - declares call, it is a check;
    - declares raise, the player must make at least a minimum bet.
    - A player declaring check when facing a bet may; call or fold but cannot raise.

BLIM

#### **COLLUSION**

- 75. a. Each player in a poker game is required to play only in his own self-interest.

  Any behaviour designed to assist one or more players over another is prohibited.
  - b. Only one player is permitted to a hand, and he must make all decisions without advice from anyone else.
  - c. Any information about a folded hand that is given to one active player in a pot must be shared with all the active players in a pot. Any information about the hand of a player who made an uncalled bet that is given to one player must be shared with all the other players.
  - d. A player acting on advice from any other person, after failing to protect their hand, may at the discretion of the Area Manager and/or Casino Manager, be deemed to be holding a dead hand.
- 76. a. Except per rule 76b and 76c conversation in a foreign language at or near a poker table is forbidden.
  - b. The house may permit cash games and tournaments exclusively for people using a language other than English providing that all such participants share that other language. The Tournament Director may nominate an interpreter or interpreters of that language for the duration of the tournament or game.
  - c. A language other than English shall include AUSLAN.



#### SCALE FOR DEDUCTIONS OF CHARGES

- 77. The house shall display a sign depicting the method by which charges shall be collected. Any changes to this will be subject to a minimum of three hands.
- 78. The charges shall be collected by the Dealer using any of the following methods:-

#### a. Commission

The Casino operator will charge a commission on a scale between 2% and 10% capped at a nominated amount, which will be displayed within the clear view of any poker table operating.

# b. <u>Commission with Jackpots</u>

If a table is operating with a Jackpot System pursuant to rule 114(a) the Casino Operator will deduct a nominated amount, of no less than \$1 per round of play, in addition to the commission schedule stated in rule 78 (a)

# c. Fee per hand

\$1 per person per hand on any game. If operating with a jackpot pursuant to rule 114 a) a pre-determined amount will be withheld (as determined by the Casino Operator) from this charge for the purpose of jackpot contribution.

#### d. Time Charge

Each player at a nominated table may be charged a fee per hour (or part thereof).

The fee shall be a nominated amount, which will be displayed within clear view of any poker table operating.

Time charges must be paid in advance and are non refundable.

If operating with a jackpot pursuant to rule 114 a) a pre-determined amount will be withheld (as determined by the Casino Operator) from this charge for the purpose of jackpot contribution.

#### e. Commission when 'running it multiple times'

The Casino Operator may choose to charge a nominated amount as an additional fee when players agree to the running of multiple boards or part thereof, pursuant to rule 130. This fee will be in addition to stated commission structures and displayed within clear view of any poker table operating.

# f. Seating Fee

The Casino Operator reserves the right to charge each player a seating fee of a nominated amount when they commence play on designated tables. This will be displayed within clear view of any poker table operating.

# q. Purchasing time when playing on express tables

A player may be given the option to buy additional time when playing on designated express tables pursuant to rule 53c. This fee will be a nominated amount which will be displayed within clear view of any poker table operating.\_\_



# **GENERAL PROVISIONS**

- 79. The house reserves the right to invalidate an outcome of the game under the following circumstances:
  - a. If any cards are found to be short or in excess of those originally issued at the start of play.
  - b. If the game is disrupted by civil commotion, fire, riot, brawl, robbery, medical emergency or an Act of God.
  - c. If there is a fraudulent act by any player or Dealer.
- 80. No player shall be advised by any employee of the Casino on how to play his hand, except to ensure compliance with these Rules.
- 81. The House reserves the right to close any gaming table at its own discretion, subject to prior notification of 15 minutes notice or a declaration of the last three rounds of play being made. In the instance where last 15 minutes is called signage will be displayed at the table, which indicates the table's imminent closure.
- 82. In any dispute not covered by the provisions of these Rules, the house decision shall be final, subject to a review by the Government Inspectorate, if requested in writing.
- 83. In any dispute arising from these Rules, the house decision shall be final, subject to a review by the Government Inspectorate, if requested in writing.
- 84. Complainants in all unresolved disputes under Rules 82 and 83 shall be advised of their right to consult a Government Inspector when present or, of their right to request a review by the Government Inspectorate in writing.
- 85. a. No player shall possess with the intent to use or actually use at the game, or communicate during the game with any other person or persons possessing with the intent to use or actually using at the game or elsewhere, any calculator, computer, or other electronic, electrical or mechanical device to assist in projecting or affecting an outcome at the game or in keeping track of or analysing the cards having been dealt, the changing probabilities of the game or the playing strategies to be utilised at the game.
- 86. A copy of these Rules shall be made available upon request for perusal in the Adelaide Casino, or for purchase.



### **TOURNAMENT PLAY**

87. In addition to the rules set out in the preceding paragraphs hereof the following rules are to apply in the case of tournament play. Where the rules for tournament play are inconsistent with the rules in the preceding paragraphs hereof then the rules for tournament play shall prevail to the extent of the inconsistency and only during the playing of a tournament.

# **DEFINITIONS**

- 88. The following definitions apply only for the purposes of the rules of tournament play set out hereunder.
  - a. "Hand" shall mean a period of play concluding when the Dealer announces a result and pay out winnings in accordance therewith.
  - b. "Session" shall mean a period of play of a duration determined by time, or a number of hands.
  - c. "Heat shall mean the completion of a session or series of sessions at which a winner or winners and place-getters, as applicable, are determined for advancement to further heats or a final.

### **CONDITIONS**

89. Management reserves the right to cancel or alter any event at its' sole discretion in the best interests of the casino or its' players

The Casino may determine the following:-

- a. The amount of any Entry Payment
- b. The amount of a Prize Pool Contribution
- c. The amount of an Adelaide Casino Entry Fee
- d. Table limits.
- e. The number of Players who can enter the tournament
- f. The allocation of Players to sessions.
- g. The seating of Players.
- h. The duration of each session.
- i. The prize list.
- j. When, or the amount of times a patron may enter any tournament.
- 90. An Entry Payment to enter the tournament may be required and may include a Prize Pool Contribution and an Adelaide Casino Entry Fee. The Prize Pool Contributions so charged are to be paid out by the Casino as prizes in accordance with these Rules (subject to Rules 106, 107, 108 and 109)
- 91. A player may enter more than one session in the first heat on a seat available basis. Where applicable, an entry fee and buy-in shall be required for each session entered.



#### **PLAY**

- 92. A player must be seated at the table by the time all players have been dealt complete hands in order to have an eligible hand for that round of play.
- 93. Players not present shall be dealt cards and will have their blinds posted (and antes if used) until their table stake has been exhausted.
- 94. Players may not have chips in their pockets at any time. A player who has chips in his pocket will forfeit the chips and they will be taken out of play.
- 95. A player shall not augment or reduce his bank during any session unless as an addon, re-buy or early entrant.
- 96. When only two players remain in the tournament the button shall post the small blind and act first in the opening round.
- 97. All cards will be turned face up once a player is all-in and all action is complete.
- 98. In Limit betting tournaments, there shall be a maximum of three raises per betting round irrespective of the amount of players in the hand.
- 99. Soft play may be penalised. Opponents may also be penalised at the Tournament Director's discretion.
- 100. a. The Tournament Director may require that each entrant be an Adelaide Casino Player Reward Member.
  - b. The Tournament Director may require that each entrant sign a copy of the tournament terms and conditions and or their agreement to abide by them

# **EXPRESS TOURNAMENTS**

101. Per rule 53a. and 53b the Tournament Director may schedule 'express tournaments' that have a time restriction. Such tournaments will require players to act on their hand within a certain time frame.



#### WINNERS/PLACE-GETTERS

- 102. The winner/s of each session will be the player/s at each table who has the highest value of chips remaining at the conclusion of the duration of the session.
- 103. Where at the conclusion of a session two or more players have chips of equal value, the winner and the placings of the other players (if applicable) shall be determined by the players cutting a card from a shuffled deck of cards. The winner and placegetters (where applicable) shall then be declared in order of the players with the successively highest value card. Should two or more players have cards of the same value, then those players shall repeat this procedure until the place-getters are determined. Other place-getters (if applicable) shall be determined in accordance with Rule 104.
- 104. Where, for the purposes of a particular tournament, place-getters are to be declared they shall be declared in order as follows:
  - a. The players with the successively highest value of chips after the winner to the extent required by the particular tournament
  - b. Where at the conclusion of a session, heat or final, there are less active players remaining than places as shown on the prize list, then the players who were successively the last to cease participation in the game shall be awarded the places after the last place awarded to an active Player in the particular tournament
  - c. Where two or more players on the same table cease participation in a tournament during the same hand, then the player that had gone all-in for the highest amount shall receive the higher placing. Should two players in a tournament cease participation in the same hand had gone all-in for the same amount, the player that went all-in first shall receive the higher amount. Should two or more players cease participation in a tournament at the conclusion of hands dealt on separate tables, then the player or players that had gone all-in for the higher amount shall receive the higher placing. Should two or more players cease participation in a tournament at the conclusion of hands dealt on separate tables had gone all-in for the same amount, the player closest to the dealer button shall receive the higher placing.
- 105. Where at the end of a session, heat or final a hand is still in progress the hand shall continue until that hand is completed at which time the winner and place-getters (if applicable) shall be announced.



#### **ENTRY PAYMENTS/FEES/PRIZES**

106. The Adelaide Casino may charge an entry fee to enter a tournament

Total tournament payments made by tournament entrants, less any Adelaide Casino entry fee, shall form the prize pool.

Total tournament payments made by tournament entrants include all entry payments, re-buys and add-ons etc.

The Adelaide Casino may deduct a maximum of 35% of total payments made as a fee.

- 107. The Prize pool shall be distributed as prizes. Prizes may be either cash and/or in kind.
- 108. Notwithstanding the foregoing, the Adelaide Casino may offer other prizes to players but they are to be in addition to those prizes allocated from the prize pool contributions.
- 109. If an ineligible player is deemed a winner and realized after the fact, the Adelaide Casino reserves the right to offer the applicable Prize to the next runner-up. If a player is deemed to be ineligible due to being underage then that prize is forfeit to the Crown.
- 110. A list of prizes shall be made available during tournaments once the total prize pool is known.

# TIME/HAND PENALTIES/DISQUALIFICATION

- 111. a. The Tournament Director may invoke penalties for players contravening the rules for tournament play or failing to abide by the Poker Zone's Code of Conduct.
  - b. The Tournament Director may disqualify a player that has not taken their seat within the first three levels of blinds, should the Tournament Director have good reason to believe they have no intention of playing. That player's chips will be taken out of player and removed from the table.

Penalties may include any of the following:-

- a. A Warning
- b. Time penalties of 5, 10, 15, 20, or 30 minutes. A player given such a penalty would be required to move away from the table for the duration of the time penalty. A player under such a time penalty will be dealt (dead) hands and the dealer shall take all blinds and antes as required.
- c. Hand Penalties of 3, 5, 10, 15 or 20 hands. Alternatively, a player may be given a 1, 2 or 3 hand penalty for every player at the table. A player given such a penalty will be required to move away from the table for the duration of the hand penalty. A player under such a hand penalty will be dealt (dead) hands and the dealer shall take all blinds and antes as required.
- d. Disqualification. No such player shall be entitled to a refund of any Entry Payment', 'Prize Pool Contribution' or 'Adelaide Casino Entry Fee

#### POKER JACKPOTS

- 112. Where the variation of poker in play incorporates jackpots, the approved rules of the poker variation in play will apply, except where the rules are inconsistent with the rules applicable to poker jackpots as set out in this section, in which case the rules applicable to poker jackpots will prevail.
- 113. The Casino Operator will fund the jackpot prize pool. For each Round completed at a participating table, a pre-determined amount (as determined by the Casino Operator) will be contributed to the jackpot prize pool.

# JACKPOT SYSTEM

- 114. The Casino Operator may operate one or more Jackpot Systems in accordance with the following provisions:
  - a. With respect to a Jackpot System, a table may only be an approved Texas Hold'em table or any other variation of Texas Hold'em in which players are dealt two Hole Cards and a three card Flop is dealt to the table;
  - b. A Jackpot System must operate in respect of one table or a group of tables;
  - c. Each table in respect of which a Jackpot System operates must be fitted with, or be located in close proximity to, a Jackpot Display designed, and operating to show the value of the jackpot recorded from time to time; and
  - d. The value of the jackpot recorded on the Jackpot System may be displayed on one or more electronic promotional displays in the casino.
  - e. The Royal Flush qualifying hand pursuant to rule 119 shall be clearly displayed at or in close proximity to each table operating with the Jackpot System.
  - f. Subject to rule 119 the Casino Operator shall at its discretion nominate the Royal Flush qualifying hand at the commencement of the seeded start up value.
  - g. The Casino Operator may reserve the right to change the qualifying hand at the commencement of the next trading day, subject to prior notification; and provided that the jackpot in progress is not awarded during the above mentioned notice period.
  - h. Unless otherwise notified, the jackpot qualifying hand will continue as previously configured once a jackpot has been awarded.
  - i. The Casino Operator may at its discretion add other qualifying hands for a % of the pool or designated dollar amount. All qualifying hands and prizes will be displayed.
- 115. The electronic equipment for a Jackpot System is deemed to be operating properly if:
  - a. The Jackpot System is capable of recording the amounts necessary under rule 116;
  - b. The Jackpot System is capable of recording the time for settlement of a winning jackpot Hand at each table in respect of which the Jackpot System is operating; and
  - c. The manner in which the Jackpot System operates allows the Casino Operator to read the value recorded on the Jackpot Management Console at the time for settlement.

#### **DEALING THE GAME**

- 116. At the commencement of a Round, the Dealer will activate the Jackpot Button indicating that the Round has started, causing the Jackpot System to increment.
- 117. Where a player has achieved a Royal Flush Jackpot qualifying Hand, the Casino Manager or Area Manager will record the winning Hand using the handset.
- 118. All jackpot payouts must be confirmed via the Jackpot Management Console.

### **SETTLEMENT**

119.

The Casino Operator shall at its discretion operate the Jackpot System with the Royal Flush qualifying hand as either:

- a. The Players two-hole cards in conjunction with the flop or;
- b. The Players two-hole cards in conjunction with the board consisting of the turn and/or river
  - Where a player has achieved a Royal Flush Jackpot qualifying hand on the flop, he/she will be paid 100% of the rounded Jackpot Display value.
  - Where a player has achieved a Royal Flush Jackpot qualifying hand on other than the flop he/she will be paid a % as determined by the Casino Operator of the rounded Jackpot Display value.
- 120. For the purposes of this rule:
  - a. The rounded Jackpot Display value is the value recorded on the Jackpot Display of a Jackpot System at the time of settlement, rounded up to the nearest payable amount; and
  - b. Outcomes on different tables in a group of tables are sequential, and the timing of the sequence of outcomes must be determined by the order in which the respective Area Managers and/or Casino Managers record those outcomes on the Jackpot System.
- 121. Where the Hand dealt to a player is eligible to receive a jackpot payout, the Hand will be displayed face-up on the table layout and the remaining cards in the deck sorted into Suits and counted for completeness.
- 122. The jackpot will be paid in chips, and in accordance with any applicable Minimum Operating Standards.
- 123. In a Round, where all other players have folded, a player who has an eligible jackpot Hand may table his/her cards to request the Flop. Once the Flop has been exposed, the jackpot will be recorded and confirmed in accordance with rules 117 and 118
- 124. To qualify for a jackpot payout, a player must, when requested by the Dealer, table his/her Hole Cards. Once a Hand has been folded and mucked or deemed to be a dead hand, it is no longer eligible to receive a jackpot payout.
- 125. Where a game being played comprises two or more Flops, the jackpot will be settled in accordance with the first Flop dealt only. Any subsequent Flops dealt do not apply to the jackpot.

# **POKER JACKPOT IRREGULARITIES**

- 126. At the completion of a Round, if the Dealer fails to record that Round into the Jackpot System, the Dealer will notify an Area Manager and/or Casino Manager who will ensure that the appropriate adjustment is made.
- 127. If the electronic equipment malfunctions during a Round, a Area Manager and/or Casino Manager will ensure that the appropriate jackpot contribution(s) for that Round have been made and any winning jackpot Hands paid as applicable.
- 128. If an error is made in respect of a Flop, that error will be corrected in accordance with the relevant irregularity and any jackpot then settled in accordance with the corrected Flop.

# **DEAD HANDS**

- 129. A hand shall be deemed dead for the following reasons:
  - A player's facedown hole cards have touched the muck;
  - A player holds too few or too many cards;
  - A verbal declaration of fold;
  - A player has acted on the advice of another player after failing to protect the contents of their hands (rule 75d);
  - Time to act has elapsed when facing a bet (rule 53a and 53b);
  - A player has failed to act in a previous betting round and substantial action has occurred in a new betting round;
  - An Area Manager/Casino Manager can rule a player to be holding a dead hand if deemed to be impinging on the smooth operation of the game in play.

# **RUNNING IT MULTIPLE TIMES**

130. On designated tables/games, when two players become all-in, they may have the option of running the remaining board multiple times. The pot will be split equally between each board. If, after the deduction of commission, each players share of the pot or pots is not wholly divisible by the number of players remaining who are to share the pot or pots, the higher value pot or pots will be awarded in order of which the multiple boards were dealt.

When players agree to the running of multiple boards or part thereof, any fee charged will be in addition to the commission structure posted for that game (subject to rule 78e).



# **APPENDIX 1 - TEXAS HOLD'EM - LIMITS**

# **Blind Bets**

- 1. a. An Area Manager/Casino shall determine the amount and the size of the blind bets prior to the commencement of play.
  - b. The size of the blind bets may be changed only by the agreement of all players at the table.
  - c. There shall be a minimum of two blind bets, one from each of the two players to the immediate left of the dealer button. Additional blind bets (if required) shall be made from the player to the immediate left of the previous blind bet.
  - d. No blind bet shall be an amount greater than the blind bet to its' left.

#### **FIXED LIMIT BETTING**

### **First Round**

2. There shall be a maximum of three raises (subject to Rule 68). Each raise shall be equal to the big blind bet. Remaining players may call or fold.

#### **Second Round**

3. The opening bet shall be equal to the big blind bet. There shall be a maximum of three raises (subject to Rule 68). Each raise shall be equal to the big blind bet.

#### **Third and Final Rounds**

4. There shall be a maximum of three raises (subject to Rule 68). All bets and raises shall be equal to double the big blind bet.

# **Two Players Only**

5. If any round is being contested by only two players, they shall be permitted to raise and re-raise each other until their table stake is expended (except per rule 98)

### Antes

- 6. a. All of the above betting limits shall require the use of two-blind bets and may be played with or without antes.
  - b. Should antes be used, they are in addition to blind bets. The two players to the immediate left of the dealer button would be required to post their blind bets in addition to an ante.
  - c. A Casino Manager/Area Manager shall determine the use and size of an ante prior to the commencement of play.
  - d. An ante shall be a nominal amount not exceeding the big blind bet

# Straddle bets

- 7. a. At the discretion of a Casino Manager and/or Area Manager, straddle bets shall be permitted on particular tables and games
  - b. Each straddle bet must be an amount equal to double the previous bet. A player to the immediate left of the big blind or the previous straddle bet shall be permitted to make a straddle bet.
  - c. Straddle bets must be made before the cards are cut at the start of a hand.
  - d. More than one straddle bet per hand is permissible. Each player may make one straddle bet providing they have either the big blind bettor or another straddle bettor to their immediate right
    - e. The last person to bet make a straddle bet, shall have the right to act last in the first betting round. In turn the straddle bettor may raise his or her straddle bet.
    - f. Pre-flop raises must be a minimum of the biggest straddle bet.
    - g. A single unannounced over-chip placed prior to the cards being cut, by a player first to act in the initial being round shall be deemed to be a straddle bet.

# **Alternative Betting Limits**

- 8. The maximum betting limits per betting round, may be any of the following:
  - a. Half Pot Limit
  - b. Full Pot Limit
  - c. No Limit

When any of these alternative betting limits are used, the opening bet shall be equal to or greater than the big blind bet (subject to rule 48).

There shall be no restriction on the amount of raises in any of these alternative betting limits.
